## WNKT's "NASCAR" CONTEST OFFICIAL RULES

  - Send a text message with the keyword as determined by the announced, spelled correctly to (803) 404-6100 during the Contest Period. All entries must be received by 3 PM on THURSDAY, 3 APRIL 2025, to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider
- 4. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
